The Auburn Wastewater Management Association was registered with the Secretary of State, registered with the IRS as a non-profit, and elected board members. The sewer project has moved toward final design approval with DEP. Prior to design changes the Town had 80% of right of ways and easements filed and user agreements in the process of being signed. The bond ordinance adoption process is was completed in early 2020.
