SECTION II: NARRATIVE

Introduction/Executive Summary

Chester, incorporated in 1907, is the northern most city in the state of West Virginia. It rests between the borders of Ohio and Pennsylvania. Its current claim to fame is that it is home to the "World's Largest Teapot" (a popular roadside attraction) but was formerly known as the home to Rock Springs Park. Rock Springs Park was a popular amusement park and attraction up until 1970. Like most cities in the Ohio River Valley, pottery was the major industry and employer. Today, many of our residents' employers operate outside Chester city limits. Mountaineer Race Track & Gaming Resort, Homer Laughlin China, the Ergon refinery, Beaver Valley Nuclear Power Station, and several other coal fired power plants employ many Chester residents.

Chester is proud to offer 24/7 local police coverage; a street department and the Chester Volunteer Fire Department offers 24/7 fire protection and fire prevention outreach to Chester and the surrounding area. Chester's water and sewer services are provided by the Chester Water Department (an autonomous public utility). Chester is home to the award-winning A.T. Allison Elementary School, which holds grades pre-K through 4th grade. The Lynn Murray Memorial Library resides in the same complex as the elementary school and has served the community for many years. Chester is home to three city parks, including Chester City Park, a large multi-use park which contains our new Davis Brothers Pharmacy Pavilion (a permanent stage for entertainment purposes). All our parks are maintained by the Chester City Park Board.

The actual home to the City of Chester offices is the former Chester High School. Chester has repurposed this building as an office, council chambers, a police station, court room, home to the Chester Water & Sewer Department in addition to several local businesses and a church. It also serves as a community center, where our citizens conduct birthday parties, dances, basketball games, and wrestling matches. Chester is also home to several non-profit organizations which includes the American Legion Post 121, Veterans of Foreign Wars Post 6450, Chester Lions Club, Chester Beautification Committee, Chester Historical Society, several church organizations, and other types of volunteer-based groups. These groups are the life blood of Chester, providing much needed services and outreach to our area and its residents. Visitors to our city often comment on how kind and welcoming our citizens are, the ultimate compliment for our city and a source of pride for all.

As of the 2010 US Census, Chester is home to 2,585 citizens, steady decline since the peak of our population (3,805) in the 1940s. This is a significant factor to the decline in the city's revenue, but not the only cause. In the early 2000's, Chester benefited greatly from the addition of casino gaming to the Mountaineer Race Track & Gaming Resort. A portion of the gaming proceeds was given to the local municipalities and served as a major source of income. However, as gaming revenue has declined over the past few years due to competition, so has revenue. Chester had become dependent on this revenue to be able to pay for anything other than the

basic day to day operation; i.e. road repair and reconstruction; the purchase of vehicles and large equipment; beautification and infrastructure projects; in addition to increases in the cost of doing business. Chester has reached the point where it is barely able to function without cutting services or employees. Infrastructure concerns have been voiced by potential new industries and businesses. Budgets have been trimmed, purchases have been cancelled and its employees have gone long periods of time without a cost of living increase. West Virginia State law restricts the City of Chester's ability to regularly and effectively generate revenue for essential services and economic development in a manner and method consistent with local resources and current economic conditions. Therefore, it is in the best interest for Chester, West Virginia to seek Home Rule status.

Without an increase in revenue, Chester will be forced to borrow money without a clear ability to pay it back. Services will be cut and our hard-working employees will face reduced hours or complete lay off. Our citizens will be negatively impacted and infrastructure will continue to deteriorate. The Ohio River Valley is about to become the epicenter of oil and gas development in the United States and Chester is in unique position to grow and prosper; however, it needs to be able to service this industry with an appropriate level of infrastructure and amenities. The prospect of losing out to neighboring communities and therefore missing out on years of prosperity and growth is real. Action is proposed below in the form of this application for Home Rule.

This Home Rule application from the City of Chester identifies the following Home Rule powers which it seeks in these central themes. Authority to enact a municipal sales tax of 1% with a reduction in municipal business & occupation tax (B&O). This authority would allow Chester to place a tax of 1% on sales within the corporate boundaries, while reducing the rate of its business & occupation taxes.

Due to declining revenue, Chester feels that this step is an appropriate way to help ensure general long-term viability, pay for infrastructure projects, and maintain a high level of service, all while spreading or reducing the tax burden on the business community and citizens. A sales tax allows the city to broaden its tax base beyond the citizens and local businesses to non-residents using city services for their work or business.

Specific Legal Barrier

§8-13C-4. Municipal sales and services taxes.

- (b) Alternative municipal sales tax on and after the first day of July, 2015, notwithstanding subsection (a) of this section, and in addition thereto in the case of qualifying municipality, any municipality that does not impose, or cease to impose, the business and occupation or privilege tax authorized by section five, article thirteen of this chapter has the plenary power and authority to impose, by ordinance, an alternative municipal sales and service tax at a rate not to exceed one percent, subject to the provisions of this article: Provided, That:
- (1) The tax does not apply to any purchase of tangible personal property, custom software or the results of taxable services in a transaction completed within the corporate limits of the municipality before the first day of July 2017, or before such later date specified in the ordinance of the municipality imposing the tax; and (2) the effective date of the tax, or of a change in the tax, shall be no earlier than the first day of the calendar quarter that a minimum begins one hundred eighty days after notice of the tax, or of change in the rate of tax, is provided to the Tax Commissioner as provided in section six of this article.

Specific Issues

Prior to the enactment of the Municipal Home Rule Program, West Virginia Code §8-1-5a, municipalities could only impose a municipal sales and use tax if it repealed the Business & Occupational Tax, according to West Virginia Code §8-13C-4. In as much as the City of Chester already faces challenges due to the recession, declining Lottery and Table Game Revenues, and the need for major capital investments and infrastructure improvements elimination of the B&O Tax revenue would be devastating. Currently Chester will procure approximately \$365,000.00 in revenue during the 2019-2020 fiscal year from their Business & Occupation tax and imposing a 1% Sales and Use Tax would generate approximately \$257,511.61 additional net revenue. Hence the total elimination of the B&O Tax would not be an economically sound financial decision. Also, an elimination of the current Business & Occupation tax would cause the City to lose additional revenue from entities that are not required to pay a sales tax, such as professional services, groceries, gas, and even construction.

As such, the City of Chester is looking for authority to enact a municipal sales tax of 1%, with a reduction in municipal business & occupational tax within the corporate boundaries. In order to maintain and improve essential services and infrastructure, a 1% sales tax is the most

prudent way to help stabilize the long-term financial future, while placing a minimal tax burden on the cities citizens.

Proposed Solution

If approved for the City of Chester, Home Rule would provide the tools necessary to improve infrastructure and services we provide to all. With a municipal Sales and Use tax of 1% and the retention of some of our B&O tax revenue, the city can utilize the opportunity to make strides in the right direction. The City of Chester would propose, upon approval of the 1% Sales tax, B&O tax upon two categories; amusements and rents & royalties would be eliminated. B&O Tax rates in two categories; retail would decrease from .0023 to .0018 and service business would decrease from .0029 to .0025. Making these adjustments would benefit the citizens and small businesses and help alleviate the tax burden upon those that own rental properties, in addition to reducing administrative costs in those categories. The City of Chester will undertake an annual review of all of our B&O rates in order to see if more reductions can be prudently enacted.

Fiscal & Economic Benefit of Proposed Solutions

The City of Chester could expect a net fiscal benefit of approximately \$257,511.61 annually with an approval of the Home Rule application. This increase in our budget will enable the City to continue making improvements to infrastructure and services. Currently the city only budgets \$20,000 for maintenance of streets and repaving, which is woefully insufficient. Approval of Home Rule Application would give it the means to substantially increase the budget allowing for the purchase of much-needed equipment for our police department.

In a nutshell, the City of Chester is a small community that could prosper substantially because it is potentially in the center of the oil and gas development; however it needs to be able to provide the services, infrastructure, and amenities that the businesses require.

The average retail sales for the past four fiscal years are \$31,209,941.70.

The City is estimating that of the total retail sales approximately 1,209,941.70 are tax exempt per the WV Code on exemption of sales tax.

By eliminating the B&O tax collected on Amusements and Rents & Royalties, and by reducing the tax rate on retailers and service business, we estimate a reduction in our B&O taxes collected for the 2019/2020 fiscal year to be \$25,488.39.

Administrative Matters

If approved, the Municipal Sales and Use Tax would be completely administered, collected, and enforced by the Tax Commissioner at the same time and in the same manner as the State Consumer Sales and Service tax and Use Tax. Once a quarter, the State Treasurer will send to the City of Chester the amount of tax owed to the City pursuant to WV Code §8-13C-7. The city understands and intends to coordinate the increase and sales tax and the decrease/elimination of the B&O Tax on the same date to avoid any sort of budget issues.

Boundary Database

Any municipality that imposes a sales tax is required to provide the Tax Commissioner with a boundary database, which the City of Chester will submit to the State Tax Commissioner in the format required if Home Rule is approved. The information provided will include all of the 9-digit zip codes that are located in whole, or in part, within our city limits.

Conclusion

The City of Chester strives to provide the best services and infrastructure that is possible within its budget. The opportunity to impose the 1% sales tax would give the City the ability to better prepare respond and foster continued growth economically and to provide better services to our citizens. Without the ability to charge Municipal Sales and Use Tax the City of Chester will be in an extremely difficult financial situation rather soon.

As part of the feasibility study for the proposed Home Rule authority for the City of Chester, WV with respect to the establishment of a %1 sales tax and reduction of certain B&O Taxes, Chester provides the following background and information:

An Ordinance of the City of Chester, West Virginia,
Authorizing the Application to The Municipal Home Rule Board to Participate in The
Home Rule Program Under West Virginia Code §8-1-5a

WHEREAS, the City of Chester is seeking to improve its economic, social, and infrastructure, and in general enhance the overall quality of life of its residents; and

WHEREAS, the City of Chester finds that certain West Virginia statues, policies, and rules are making the City's efforts in these regards overly difficult and cumbersome; and

WHEREAS, pursuant to West Virginia Code §8-1-5a(a)(7)(b), which was effective on June 7, 2019 the West Virginia Legislature granted the Municipal Home Rule Program permanent status; and

WHEREAS, The City of Chester is defined to be a Class III city under state law, and so is eligible to participate in said Program; and

WHEREAS, the Common Council further finds that participating in the Municipal Home Rule Program is in the public interest; and

WHEREAS, the City of Chester's participation in the Municipal Home Rule Program would allow the City a reasonable flexibility to efficiently, effectively, and responsibly pursue and achieve its aforementioned goals;

Re: Application of the City of Chester

West Virginia Municipal Home Rule Program Application

Dear Board Members:

We have acted as counsel to the City of Chester in connection with its application to the West Virginia Municipal Home Rule Application. For purposes of the opinions contained in this letter, we have examined West Virginia Code §8-1-5a, the Municipal Home Rule Application Guidelines, and the Municipal Home Rule Application of the City of Chester (the "Application"). As to any facts relevant to our opinion which we did not independently establish, we have relied upon factual representations contained within the Application and any documentation submitted contemporaneously therewith.

We find that the Application does not include proposals that will make changes to ordinances, acts, resolutions, rules, and regulations contrary to environmental laws; bidding on government construction and other contracts; the Freedom of Information Act; the Open Governmental Proceedings Act; wages for construction of public improvements; the provisions of West Virginia Code §8-1-5a; the City of Chester's written plan. Further, we find that the Application does not propose to pass any ordinance, act, resolution, rule, or regulation pertaining to the Constitution of the United States, the Constitution of the State of West Virginia; Federal law or crimes and punishment; Chapters 60A, 61, and 62 of the West Virginia Code or other state crimes and punishment; pensions or retirement plans; annexation; taxation; tax increment financing; extraction of natural resources; marriage and divorce laws; laws regarding professional licenses or certification; regulations regarding state buildings and fire codes; Federal laws affecting the state's compliance with or jeopardize federal funding; rules governing engineering or architecture services; the provisions of West Virginia Code Chapter 17C; laws governing communication technologies or telecommunications carriers; laws governing firearms or accessories thereof; persons or property outside the boundaries of the City; imposes unpermitted duties upon other government entities; or imposes an occupation tax, fee, or assessment payable by a nonresident of a municipality, except to

the extent that the Application proposes a municipal sales tax of up to one percent in connection with the reduction of the City of Chester's Business and Occupation Tax, as to amenities, rents, retailers and service businesses, as permitted by West Virginia Code §8-1-5a(i)(14).

Finally, as evidenced by the documentation enclosed with the Application, the City of Chester made available a copy of the Application for public viewing and published thirty days' advance notice of a public hearing on the Application, conducted such a public hearing, and adopted an ordinance authorizing the City of Chester to submit the Application. Further, as evidenced by the documentation enclosed with the Application, the City of Chester is current in payment of all state fees.

Based upon the foregoing, we opine that the City of Chester's Application for participation in the West Virginia Municipal Home Rule Program does not violate the provisions of West Virginia Code §8-1-5a. This opinion is solely for the benefit of the Municipal Home Rule Board in connection with the Application of the City of Chester to the WV Municipal Home Rule Program, and without our written consent, this opinion letter may not be used or relied upon by any other person for any purposes whatsoever.
