Proposed Amendment to the City of Follansbee Municipal Home Rule Written Plan

To Permit Certain Alcohol Beverage Control Administration (ABCA) Class "A" License Holders to Sell Alcoholic Beverages Beginning at 10:00 a.m. on Sundays

Municipal Classification

With a population of approximately 2,985 residents, the City of Follansbee is classified as a Class III city.

Introduction

Follansbee is a city in Brooke County, West Virginia, located along West Virginia Route 2, which doubles as the City's Main Street, and adjacent to the east bank of the Ohio River (hereinafter, "Follansbee" or the "City"). The City is part of the Weirton-Steubenville, West Virginia-OH Metropolitan Statistical Area.

The City is located:

19.39 miles north of Wheeling, West Virginia

6.33 miles south of Weirton, West Virginia

45.00 miles west of Pittsburgh, Pennsylvania

3.91 miles east of Steubenville, Ohio

Follansbee first received its municipal charter in 1906. Today, it has an estimated population of 2,985 persons and an estimated median household income of \$46,501.00. The City is known throughout the State of West Virginia and the Ohio Valley as the home of Community Days and Christmas in the Park. Every summer and fall thousands of people from West Virginia and surrounding areas travel to the City to attend these events. The City likes to think of itself as small town USA and was recently rated as the ninth least expensive and nicest City in which to live in West Virginia. The City continues to grow and in an effort to continue this trajectory the City would like to amend its Home Rule Application Written Plan in the following manner.

The City proposes a plan to allow the sale of alcoholic beverages by certain ABCA Class "A" license holders beginning at 10:00 a.m. on Sundays.

Problem Being Addressed

The West Virginia Code currently prohibits restaurants and bars from serving alcohol before 1:00 p.m. on Sundays. Local businesses, restaurants, and hotels are turning away business because patrons are traveling to other areas in or near the Northern Panhandle to enjoy adult beverages with their Sunday brunches.

Follansbee is home to many local restaurants which have lost business and revenue as other jurisdictions adopt standards permitting alcohol sales with Sunday brunch activities. The addition of Sunday alcohol sales would present these visitors with additional local amenities and boost the local economy. Several home rule municipalities have already obtained approval to use the program to implement municipal ordinances permitting Sunday alcohol sales for on premise consumption beginning at 10:00 a.m. Follansbee wishes to join these communities in exercising local authority to expand opportunities for residents, businesses, and visitors.

Proposed Solution

Senate Bill 293, passed during the 2016 regular session, signed into law, and made effective June 10, 2016, modifies these limitations by permitting on premise alcohol sales beginning at 10:00 a.m. on Sundays only after an election. An election approving Sunday alcohol sales has not yet occurred in Brooke County. Follansbee, however, is a participating city in the West Virginia Municipal Home Rule Pilot Program and the Municipal Home Rule Board (the "Board" approved its initial written plan on July 10, 2016. Pursuant to W. Va. Code §8-1-5a(l), "[a] municipality selected to participate in the Municipal Home Rule Pilot Program may amend its written plan at any time." The Board has provided guidance for municipalities proposing plan amendments. Cities that have been approved as Home Rule cities are permitted to modify the time at which alcohol may be served on Sundays within their cities, and such a modification is the type of innovative solution that was intended by the Legislature when it enacted the Municipal Home Rule Pilot Program.

Conclusion

The City wishes to adopt an ordinance permitting alcohol sales by ABCA Class A license holders for on premise consumption beginning at 10:00 a.m. on Sundays. By allowing these sales, it will result in an overall enhancement and positive economic development for businesses within Follansbee.

ORDINANCE

An **Ordinance**, authorizing the City of Follansbee to submit an amendment to the City's written plan to the Municipal Home Rule Board which will allow the sale of alcoholic beverages by certain alcohol beverage control administration Class "A" License holders beginning at 10:00 am on Sundays.

WHEREAS, the West Virginia Municipal home Rule Board approved the Municipal Home Rule written plan of the City of Follansbee, Class III municipality, on July 11, 2016;

WHEREAS, the owners of restaurants and hotels in the City have indicated that there is a market for brunch services on Sunday and the current restrictions on the hours of Sunday alcohol sales imposed by state Law are not conducive to practical and successful Sunday morning brunch attendance;

WHEREASE, the City's hospitality and tourism industry fully supports the City's use of Home Rule to allow earlier Sunday alcohol service in Follansbee thereby enabling restaurants and hotels in the City to be fully operational on Sunday to enhance the City's image in the eyes of business and leisure travels as well as to enrich the overall experiences that visitors have in Follansbee; and ,

WHEREAS, the City has determined that allowing alcohol sales at Sunday morning brunch within the city will produce more tax revenue and strengthen the businesses in the City, while also increasing the earnings for servers and other hospitality employees working in the City,

NOW, THEREFORE, BE IT ORDAINED BY THE COUCIL OF THE CITY OF FOLLANSBEE, WEST VIRGINIA, THAT;

SECTION 1: The Mayor is hereby authorized and directed to submit to the Municipal Home Rule Board a proposed amendment, attached hereto as exhibit A, to the City of Follansbee's Municipal Home Rule Plan in accordance with the requirements of W.Va. Code §8-1-5a, requesting approval to allow the sale of alcoholic beverages by certain Alcohol Beverage Control Administration Class "A" license holders beginning at 10:00 a.m. on Sundays. The Mayor and the City Administration are further authorized to do all things reasonable necessary to obtain approval by the Municipal Home Rule Board of the City's amendment to the written plan.

SECTION 2: This Ordinance shall be effective immediately upon adoption.

Mr. Chairman Designee and Members of the Board:

We have acted as counsel to the City of Follansbee in connection with the amendment to its approved Home Rule Application. For the purposes of the opinions contained in this letter, we have examined West Virginia Code §8-1-5a, the Municipal Home Rule Pilot Program Phase III Application of the City of Follansbee (the "City") and the corresponding Amendment. As to any facts relevant to our opinion which we did not independently establish, we have relied upon factual representations contained within the Application, the Amendment, and any documentation submitted contemporaneously therewith.

We find that the Application for Amendment does not include proposals that will make changes to ordinances, acts, resolutions, rules, and regulations contrary to environmental laws, bidding on government construction and other contracts, the Freedom of Information Act, the Open Governmental Proceedings Act, wages for construction of public improvements, the provisions of West Virginia Code §8-1-5a, the provisions of West Virginia Code §8-12-5a, or the City's Written Plan. Further, we find that the Application for Amendment does not propose to pass any ordinance, act, resolution, rule, or regulation pertaining to the Constitution of the United States of America, the Constitution of the State of West Virginia, federal law or crimes and punishment, Chapters 60A, 61, and 62 of the West Virginia Code or other state crimes and punishment, pensions or retirement plans, annexation, taxation, tax increment financing, extraction of natural resources, persons or property outside the boundaries of the municipality, marriage and divorce laws, or an occupation tax, fee, or assessment payable by a nonresident of the municipality.

Finally, as evidenced by the documentation enclosed with the Amendment, the City made available a copy of the Amendment to its Home Rule Written Plan for public viewing and published thirty days advance notice of a public hearing on the Amendment, conducted such a public hearing, and adopted an ordinance authorizing the City to submit this Amendment.
