# City Of Martinsburg Special City Council Meeting Minutes Thursday, June 30, 2016 5:00 P.M.

With a quorum present, the special session of the Martinsburg City Council was called to order by Mayor George Karos at 5:00 p.m. The following Council Members were present: Dennis Etherington, Kevin Knowles, Gregg Wachtel, Ken Collinson and Jason W.
