Collection began July 1, 2017. To date we have received \$222,101.69.	
Beginning July 1, 2017, the B&O tax rate for Retail was reduced from .0015 to .0005. The reduced rate resulted in a revenue loss of \$40,678.17 since July 1, 2017.	
The net revenue gain because of the 1% tax is \$181,423.52 to date.

New Cumberland has used the revenue to supplement our general budget and the daily operations of the City. We have addressed many outstanding Street projects and provided for increased work forces in the summer. A much-needed vehicle for the Streets Department has been purchased. We hope to use the increased revenue to begin paving projects throughout the City in the Spring.
