## I. Introduction

In accordance with West Virginia State Code § 8-1-5a(n), the Municipal Home Rule Board (the “Board”) respectfully submits this annual summary report to the West Virginia Legislature’s Joint Committee on Government and Finance. This report summarizes the Board’s work during 2024, documents how municipalities have taken advantage of Home Rule to develop new solutions to old problems, and provides a reference tool for anyone interested in reviewing the West Virginia Home Rule Program.

In 2007, the West Virginia Legislature created the Municipal Home Rule Pilot Program and the Board to oversee the program. The pilot program, which was set to expire on July 1, 2013, provided participating municipalities broad-based home rule freedom to be creative in addressing local issues by implementing ordinances, resolutions, rules and regulations not otherwise available because of the one-size-fits-all State statutes that apply to West Virginia municipalities. At the same time, Home Rule municipalities must comply with the U.S. Constitution; the West Virginia Constitution; federal law; and chapters 60A (Uniform Controlled Substance Act), 61 (Crimes and Their Punishment), and 62 (Criminal Procedure) of the West Virginia Code. The 2007 legislation authorized up to five municipalities to participate in the program. The Board approved Bridgeport, Charleston, Huntington, and Wheeling as the initial participants.

The West Virginia Legislative Auditor published a Special Report regarding the Home Rule Pilot Program in November 2012. This report discusses the accomplishments of the participating municipalities, evaluates the effectiveness of the Program, and offers the following recommendations regarding the future of the Program:

1. The West Virginia Legislature should consider providing broad-based home rule authority to all Class I, Class II, and Class III municipalities.
2. If home rule is extended to all Class I, II, and III municipalities, the current restrictions as stipulated in the Pilot Program should be retained.
3. The Home Rule Board should be discontinued if broad-based home rule is granted statewide.

In 2013, the West Virginia Legislature amended the Home Rule statute. These amendments include legislative findings that the Pilot Program had afforded participating municipalities the flexibility to be innovative in addressing local issues in a cost-effective, efficient, and timely manner. In fact, some of the ordinances adopted by Home Rule municipalities are now part of the West Virginia Code.

The 2013 amendments opened the Pilot Program to 20 more municipalities; gave the four participating municipalities until June 1, 2014, to withdraw from the Program (no municipalities withdrew); and set June 1, 2014, as the deadline for new municipalities wishing to participate in the Program to submit their written plan to the Board.

On October 6, 2014, the Board accepted the following 16-cities into the Pilot Program: Bluefield, Buckhannon, Charles Town, Clarksburg, Dunbar, Fairmont, Martinsburg, Milton, Morgantown, Nitro, Parkersburg, Ranson, Shinnston, South Charleston, Vienna, and Weirton.

The Legislature amended the Home Rule statute again in 2014. These amendments prohibit participating municipalities from passing ordinances that conflict with any state statutes regarding the purchase, ownership, carrying, and storage of certain firearms and ammunition. The Legislature rewrote the Home Rule statute in 2015, when it opened the Pilot Program for an additional 14 municipalities, four of which had to be Class IV municipalities.

Six new cities were granted home rule authority on September 14, 2015. The applications submitted by Beckley, Grafton, Princeton, and St. Albans were approved as submitted, while the applications submitted by Moundsville and Oak Hill were approved with modifications. Elkins and Harpers Ferry were granted home rule status on November 16, 2015.

On April 4, 2016, Auburn, Lewisburg, New Cumberland, and Shepherdstown were granted home rule authority. Follansbee and Weston were approved as Home Rule cities on July 11, 2016.

With the passage of Senate Bill 4 during the 2019 legislative session, the Municipal Home Rule Program became permanent. The legislature made several changes to the program including the assessment of an annual fee of \$2,000.00 to Home Rule municipalities to fund the operation of the program and allowing up to four Class IV municipalities to be admitted to the program each year.

During 2019, Barboursville, Wardensville, Ravenswood, Ripley, Hurricane, New Martinsville, Logan, and Montgomery were admitted to the Municipal Home Rule Program.

During 2020, six new municipalities were added to the program, namely Chester, Man, Nutter Fort, Smithers, Sophia, and Spencer.

During 2021, five new municipalities were added to the program. Fayetteville, which is a Class III municipality and Chapmanville, Reedsville, Alderson, and Ansted, which are all Class IV municipalities. The statute allows four Class IV municipalities to be added to the West Virginia Municipal Home Rule Program annually. An additional four municipalities may be added in 2022.

During 2022, four new municipalities were added to the program. Hinton, Mannington, and Summersville, which are all Class III municipalities. Romney was the only Class IV municipality added this year. Additionally, during FY 2022, the Home Rule

Board Operations Fund reached an amount in excess of \$200,000. As stated in West Virginia Code § 8-1-5a(c)(7), "...annual assessments shall be suspended until the Board determines that the unencumbered balance in the fund is insufficient to meet operational expenses. The board shall notify all participating municipalities of the suspension of the annual assessment prior to the end of the fiscal year and provide an estimate of when payment of annual assessments will resume." The Board mailed out a notice to all Home Rule cities suspending the annual fee in April 2022.

During 2023, two new municipalities were accepted into the Program. Westover and Richwood attended the only meeting held by the Board this year. Richwood was the only Class IV municipality added this year. The Home Rule Operations Fund remains in excess of \$200,000, and the annual assessments are still suspended at this time.

In 2024, the Board held three regular quarterly business meetings. Five new municipalities were accepted into the Program. Pineville, Anmoore, Marlinton and St. Marys, all Class IV municipalities, as well as Winfield, a Class III municipality. The Home Rule Operations Fund remains in excess of \$200,000, and the annual assessments continue to be suspended to this date.

There are now 64 municipalities participating in the Program.

This report summarizes the issues considered by the Board in 2024, and includes a compilation of the annual Progress Reports submitted to the Board by each of the 64 Home Rule municipalities in West Virginia.

## II. 2024 Home Rule Board Recap

There were three regular quarterly meetings of the Home Rule Board during 2024. The meetings were held in Charleston. The following tables summarize the actions of the Board during 2024:
