City of Huntington

- Land Bank Fast Track Authority A motion was made by Mr. Jon Amores to approve this section of the application. The motion was seconded by Mr. Chris Fletcher and unanimously carried. Member Jim Morgan abstained from voting.
- Local Options for Addressing Fire Damage to Residential/Commercial Structures – A motion was made by Mr. Chris Fletcher to approve this section of the application. The motion was seconded by Mr. Brian Jones and unanimously carried. Member Jim Morgan abstained from voting.
- Increased Capacity to Collect City Fee/Taxes A motion was made by Mr. Brian Jones to approve this section of the application. The motion was seconded by Mr. Jon Amores and unanimously carried. Member Jim Morgan abstained from voting.
- 4. Municipal Occupation Tax/Municipal Retail Sales Use Tax A motion was made by Mr. Jon Amores to approve this section of the application. The motion was seconded by Mr. Brian Jones and unanimously carried. Member Jim Morgan abstained from voting. It was noted by several board members that the financial analysis of this item was not very detailed.

City of Bridgeport

- Restrictions on Municipal Participation in Public Schools A motion was made by Mr. Chris Fletcher to approve this section of the application. The motion was seconded by Mr. Brian Jones and unanimously carried. Members Jim Morgan and Edwin Bowman abstained from voting.
- Requirement that the Municipality Charge License Taxes Not to Exceed Antiquated Amounts Previously Authorized by the State – A motion was made by Mr. Brian Jones to approve this section of the application. The motion was seconded by Mr. Jon Amores and unanimously carried. Members Jim Morgan and Edwin Bowman abstained from voting.
- The City is Not Allowed, Under Certain Circumstances to Annex Property that the City is in the Best Position to Provide Public Services – A motion was made by Mr. Brian Jones to approve this section of the application. The motion was seconded by Mr. Jon Amores and carried. Members Chris Fletcher and Kin Sayre were opposed. Members Jim Morgan and Edwin Bowman abstained from voting.
- 4. The City of Bridgeport Cannot Issue Its Own Tax Increment Financing Because It is a Class III City – A motion was made by Mr. Kin Sayre to approve this section of the application. A motion was made by Mr. Jon Amores to accept the City of Bridgeport as a participant in the five year municipal home rule pilot program with a termination date of July 1, 2013. The motion was seconded by Mr. Ken Sayre and unanimously carried. Members Jim Morgan and Edwin Bowman abstained from voting.

City of Wheeling

- Special Charges for Municipal Services A motion was made by Mr. Kin Sayre to amend this section of the application to clarify that the municipal lien be of the same rank and dignity as the West Virginia tax lien. The motion was seconded by Mr. Chris Fletcher and unanimously carried. Member Jim Morgan abstained from voting. The amendment was adopted. Then, a motion was made by Mr. Chris Fletcher to approve the amended section of the application. The motion was seconded by Mr. Kin Sayre and unanimously carried. Member Jim Morgan abstained from voting.
- Vacant Property Registration Program A motion was made by Mr. Brian Jones to approve this section of the application. The motion was seconded by Mr. Kin Sayre and unanimously carried. Member Jim Morgan abstained from voting.
- Municipal Planning and Zoning A motion was made by Mr. Kin Sayre to approve this section of the application. The motion was seconded by Mr. Brian Jones and unanimously carried. Member Jim Morgan abstained from voting.

A motion was made by Mr. Ken Sayre to accept the City of Wheeling as a participant in the five year municipal home rule pilot program with a termination date of July 1, 2013. The motion was seconded by Mr. Chris Fletcher and unanimously carried. Member Jim Morgan abstained from voting.

Mr. Nick Sparachane commenced chairing the meeting at the conclusion of discussions concerning the application from the City of Wheeling.

- Eyesores and Dilapidated Structures A motion was made by Mr. Chris Fletcher to approve this section of the application. The motion was seconded by Mr. Kin Sayre and unanimously carried. Member Jim Morgan abstained from voting.
- Procurement of Architect-Engineering Services A motion was made by Mr. Jon Amores to approve this section of the application. The motion was seconded by Mr. Chris Fletcher. One member voted in opposition. The motion carried. Member Jim Morgan abstained from voting.
- 5. B&O Taxing Authority -- A motion was made by Mr. Jon Amores to approve this section of the application. The motion was seconded by Mr. Kin Sayre and unanimously carried. Member Jim Morgan abstained from voting.
- Building and Zoning Administration Enforcement Provisions -- A motion was made by Mr. Chris Fletcher to approve this section of the application. The motion was seconded by Mr. Kin Sayre and unanimously carried. Member Jim Morgan abstained from voting.
- 7. Relief from Division of Natural Resources per Project Permitting It was noted that this item was removed from the application by the City of Charleston.
- Relief from per Load Department of Environmental Protection Testing Costs and Permitting – A motion was made by Mr. Kin Sayre to approve this section of the application. The motion was seconded by Mr. Jon Amores and unanimously carried. Member Jim Morgan abstained from voting.
- Disposition of City Property A motion was made by Mr. Kin Sayre to approve this section of the application. The motion was seconded by Mr. Chris Fletcher and unanimously carried. Member Jim Morgan abstained from voting.
- 10. Relief from Municipal Juror Number Requirements Deleted from original application by the City of Charleston.
- 11. Relief from Design-Build Procurement Act Requirements A motion was made by Mr. Kin Sayre to approve this section of the application. The motion was seconded by Mr. Brian Jones and unanimously carried. Member Jim Morgan abstained from voting.
- Allow Contracts with other Jurisdictions via Resolution A motion was made by Mr. Chris Fletcher to approve this section of the application. The motion was seconded by Mr. Kin Sayre and unanimously carried. Member Jim Morgan abstained from voting.

The motion was seconded by Mr. Jon Amores and unanimously carried. Member Jim Morgan abstained from voting.
