Executive Summary

The City of Beckley is a Class II city located in Raleigh County, West Virginia. Beckley is the regional hub for Raleigh County and Southern West Virginia.

The City of Beckley was accepted into the Home Rule Program by the Home Rule Board on September 10, 2015. The City has implemented all of the proposals from the original application.

The City proposes to amend its Home Rule Program application by seeking authorization to enact an ordinance permitting any private club licensee or private wine bed and breakfast or restaurant to serve beer, wine, and alcoholic liquors starting at 10:00 a.m. on Sundays.

If restaurants are permitted to offer alcoholic beverages on Sunday mornings (starting at 10:00 a.m.) the restaurants and hotels will be able to attract more customers and increase their business which in turn directly benefits the City.

Specific Problems and Solutions to be addressed by Beckley's Home Rule Plan Amendment

A. Regulate When Restaurants and Bars May Serve Alcohol to Become a Sunday Brunch Destination.

- i. Problem: West Virginia Code prohibits restaurants and bars from serving alcohol before 1:00 p.m. on Sundays. However, some neighboring states permit sales of alcohol prior to 6:00 p.m. on Sundays. Potential visitors who enjoy beverages with their Sunday brunches are not visiting Beckley when they can cross the state line to enjoy that amenity. Local residents are not frequenting local restaurants on Sundays as often as they may if alcoholic beverages were an option on Sunday mornings.
- ii. Authority: W. Va. Code § 60-7-12(a)(5) prohibits any private club licensee, or agent, employee or member thereof, from selling beer, wine, or alcoholic liquor between the hours of 3:00 a.m. and 1:00 p.m. on Sundays. Further, W. Va. Code § 60-8-34 prohibits a private wine bed and breakfast or restaurant from selling wine between the hours of 2:00 a.m. and 1:00 p.m. on Sundays. W. Va. Code § 11-16-18(a)(1) provides that it shall be unlawful for any licensee to sell beer between 2:00 a.m. and 1:00 p.m. on Sundays (except that private clubs licensed under Article 7, Chapter 60 of the West Virginia Code shall operate within hours conforming with the hours of sale of alcoholic liquor). The Governor recently signed SB 298 that authorizes County Commissions to authorize a referendum to allow alcohol sales prior to 1:00 p.m. on Sunday.
- iii. Solution: The City will enact an ordinance permitting any private club licensee or private wine bed and breakfast or restaurant to serve beer, wine, and alcoholic liquors starting at 10:00 a.m. on Sundays.

To the extent required by law, this plan shall terminate on or prior to the first day of July, 2019; however, all ordinances enacted under the provisions of this plan shall continue in full force and effect until repealed. Further, the City of Beckley will cooperate fully with any performance review conducted by the Joint Committee on Government and Finance and provide progress reports to the Home Rule Board as needed.

The above-mentioned solution will allow for sustained improvement to the City of Beckley.

WHEREAS, Chapter 14, Article III, of the Code of the City of Beckley, West Virginia, provides for the establishment of a Traffic Control Map and Traffic Control File; and

WHEREAS, it is now deemed necessary by the Common Council of the City of Beckley to amend the Traffic Control Map and the Traffic Control File in the manner provided by Section 14-302 of the Code of the City of Beckley.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BECKLEY, WEST VIRGINIA:

That the Traffic Control Map-Parking Areas and Traffic Control File of the City of Beckley be, and the same are hereby amended to provide for the removal of street parking meters on the following street sections in the City of Beckley, Raleigh County, West Virginia:

- the section of Woodlawn Avenue between Bellevue Lane and Second Street;
- the section of South Heber Street from 228 South Heber Street to where South Heber Street intersects with Second Street.

This Ordinance shall become effective upon passage.

Mr. File presented for first reading an Ordinance authorizing the City to submit to the Municipal Home Rule Board an Ordinance to amend the approved written Home Rule Plan by incorporating a "Brunch Bill" into the plan. The "Brunch Bill" will permit establishments to begin serving alcoholic liquors, wine, and non-intoxicating beer at 10:00 a.m. on Sundays for on premise consumption only as authorized by the West Virginia Legislature during its 2016 Session. If the first reading is approved tonight, the second reading and public hearing will be in two weeks. If the second reading of this Ordinance is approved, it will then go before the Home Rule Board on October 3, 2016 in Morgantown. If the Home Rule Board approves the City's application, the City will then present to Council an Ordinance to adopt the "Brunch Bill". Mr. File read the Ordinance by title only.

Councilwoman Hunter shared her concerns against passing this Ordinance while Councilmen Sopher and Williams spoke

in favor of the Ordinance. Councilman Sopher thought this Bill, if approved, might entice businesses to come into the City by annexation. On a motion by Councilwoman Worley and seconded by Councilman Sopher, the first reading of this Ordinance was approved with five Council Members voting in favor, Councilwoman Hunter voting against the Ordinance, and one Council Member absent.

Next Mr. File presented for first reading an Ordinance renaming "A" Street to Mel Hancock Way. The Mayor stated this is an excellent street to be named for Mr. Hancock because it is in the center of what is now the West Virginia Tech Campus. Mr. Hancock raised so much money for the previous university which was located there plus there are no homes or businesses that will be affected by the change on that street. On a motion by Councilman Price and seconded by Councilwoman Hunter, the first reading of this Ordinance was approved by
