Our home rule revenue did not begin until October of 2022. We did receive our first disbursement in the amount of \$45,644. Any monies to be received and monies spent are being tracked using a separate bank statement and separate deposits and checks.
Beginning July 1, 2022, the B & O rate for Retail was rolled back from .35 to .33, Service rates were rolled back from .60 to .57, Wholesale was rolled back from .15 to .12 and Manufacturing was rolled back from .30 to .20 for an estimated net loss of \$3.062.61
