Introduction and Executive Summary

Charted by the state of Virginia in 1856, reincorporated as a town by the State of West Virginia in 1872 then incorporated by the State of West Virginia in as a city in 1921, the City of Mannington is a Class III city in Marion County in Northcentral West Virginia. Mannington is the third largest city in Marion County and is fortunate, compared to many communities, in that many of the key elements necessary for revitalization are already in place. The City has a strong infrastructure evidenced by an updated sewage treatment system and water distribution system. Our state representatives have seen to it that our local bridges are given priority in Charleston and a flood control project has seen seven flood control dams constructed and a creek dredging project that has help us to resolve the flooding problems along Buffalo Creek. The City is blessed to have one of the most beautiful public parks in West Virginia and it is the site of continual activity in the spring and summer months. Many of our neighborhoods have historic homes that have been beautifully maintained and are a source of great pride. Tours of these homes are annual events.

Our downtown is alive and well with several new restaurants scheduled to open this year. A new city park was recently constructed on the site of the old Wintergarden Hotel and Restaurant which was heavily damaged in a fire several years ago and has been an eyesore since that time. It includes an amphitheater that will house numerous activities during the year including concerts, Octoberfest, visits by the Easter Bunny and Santa Claus, etc.

As a town, Mannington has had a pro-active government. For decades, the City has experienced strong volunteer support with a park board, planning commission and board of zoning appeals, sanitary board and a progressive town government that has worked to prepare for and keep pace with change in the area.

By becoming a part of the West Virginia Home Rule Program, Mannington will be able to do greater things for our town. The three issues detailed in the applications will increase our annual revenue and help us to adequately fund our police, provide for the demolition of abandoned properties and the paving of our roads; encourage new businesses to come to town and make it easier for them to do business here; and simplify our licensing process.

We want to be ready for new opportunities coming our way while at the same time, protecting the best parts of our traditional community as we embrace newcomers and encourage good growth.

CITY OF MANNINGTON

The City of Mannington seeks Home Rule authority in four areas. All four of these have been approved for other Home Rule municipalities. They are:

- Impose a 1% sales tax and eliminate selected business and occupation tax categories;
- 2. Standardize business license categories and fees; and

- 4. Eliminate partisan requirements for our building commission, ballot commission and poll workers for our municipal non-partisan elections

1. Impose a 1% Sales Tax and Reduce or Eliminate Selected Business and Occupation Tax Categories

Issue Category: Tax

Mannington seeks to restructure its business tax structure, reducing and eliminating some classes of the Business and Occupation Tax and instituting a 1% sales tax in order to increase revenues for public safety operations, paving our roads, razing dilapidated structures and supporting grant applications. This new business tax structure will be fairer and more standardized, and similar to those in adjacent communities in neighboring states.

Specific Legal Barrier

§8-13C-4

Problem Caused by Legal Barrier

Mannington has a very small residential tax base and yet, being a remote town on a busy highway, provides service to a much larger population. Presently, the Town is only able to generate revenue via taxation by imposing a municipal business and occupation ("B&O") tax or by imposing a sales tax; W.Va. state code requires that the two taxes be mutually exclusive. W.Va. Code §8-13C-1 et seq. contemplates the imposition of a sales tax by municipalities either for pension relief or as an "alternative municipal sales tax" at a rate not to exceed one percent.

The City currently imposes a B&O tax on businesses, but the B&O tax is neither a wholly fair tax on some categories nor does it provide adequate revenue to support community needs.

Under W.Va. Code §8-1-5a(i)(14), municipalities participating in the Municipal Home Rule Program do not have the authority to pass an ordinance under Home Rule pertaining to taxation, except that a participating municipality may enact a municipal sales tax up to one percent if it reduces or eliminates its municipal B&O tax. But a sales tax alone without the B&O tax would exempt certain critical town businesses (banks, insurance, real estate agents) from paying a municipal tax.

Proposed Solution

The City proposes to impose a municipal sales tax of up to 1% on all taxable sales under the West Virginia Code within the city. At the same time, it will reduce the B&O tax on selected categories—primarily manufacturers and wholesalers—that would be subject to the sales tax. In this way, most business classes would pay some form of municipal tax. The increase inannual revenue based on this plan would be approximately \$ 125,159.

Increased revenues would go to provide key municipal services, including (but not limited to):

- adequately funding our departments to provide them the necessary equipment/vehicles to operate efficiently and the wages to compete with other entities/businesses;
- support for grant programs that require partial local match, which the City cannot afford out of current operational funds; and
- paving of our deteriorating roads in all of our neighborhoods;
- razing of abandoned or condemned structures, in our neighborhoods, that discourage people moving to Mannington and provide for properties suitable for new housing.

The vast majority of W.Va. municipalities accepted into the Home Rule Program have proposed this business tax restructuring in one form or another, and it appears to be meeting with widespread acceptance and success.

2. Standardize Business License Categories and Fees

Issue Category: Administrative

Mannington seeks the authority to consolidate and reduce the number of business-license categories (currently at 50) and/or reduce the fees charged to various categories in order create a simple, flat business license for the City. This would result in a less confusing array of red tape for businesses to surmount, reduce administrative time and costs, and permit an overall reduction in paperwork in what is essentially a registration activity that is not intended to generate high revenue.

Specific Legal Barrier

Problem Caused by Legal Barrier

W. Va. Code §8-13-4 permits cities to "enact an ordinance creating an annual general municipal business license for anything which requires a state license that is done within the corporate limits of a municipality, the tax for which may not exceed twenty dollars." However, the city may not include under this "general" business license any category of business on which W.Va. Code imposes a state license fee; cities must continue to charge that fee at the municipal level as well.

Although the 2011 amendment creating the "general municipal business license" was a step in the right direction, it was a half-measure. Because cities are not yet truly free to consolidate all business licenses for all categories of business operating inside their borders, staff charged with processing such licenses are required to expend valuable time differentiating between categories of businesses for no clear public benefit.

At the same time, businesses are not treated fairly, as the license amounts assigned to different categories vary widely and do not seem based on rational distinctions between those categories. For example, as shown on the current City of Mannington Business License Fee Schedule (Appendix A), funeral homes are charged \$35 for their town business licenses, while attorneys are charged only \$5.

Finally, the current list of license rates is confusing to both businesses and administrative staff.

Proposed Solution

Mannington seeks authority to enact an ordinance expanding the authority provided under W.Va. Code §8-13-4 to allow the town to consolidate all business license categories (except for alcohol licenses), including those currently charged a state-specified fee, into one general category, for which we would establish a single universal fee of \$25. This will make licensing easier for new and existing businesses, improve the efficiency of staff and increase the perceived fairness of the town's business-licensing requirements. While the gross proceeds from business licensing will decrease slightly (see excel sheet), the resulting simplification, reduced workload and implementation of a fair standard across the board will be worth the cost.

Furthermore, the substantial increase in revenue resulting from the proposed business tax restructuring will more than make up the small loss in business license revenues.

Other cities in the Home Rule Program that have enacted similar measures include Bridgeport, Elkins and Wheeling, and it has been received positively by the business community. See **Appendix B** for the single-page Municipal License Application of the City of Elkins for an example of a successful implementation of this solution.

3. Provide relief from requirements of the sale of the City's real property

Issue Category: Organization

Mannington seeks to get relief from the notice and public auction requirements of West Virginia Code 8-12-18(b) relative to the sale of real property belonging to the City of Mannington when the value of the parcel to be sold is less than \$15,000.

Specific Legal Barrier

Problem Caused by Legal Barrier

The City of Mannington has been plagued by abandoned properties and/or out of state landlords who fail to maintain their properties. These properties present a blight to otherwise wellmaintained neighborhoods. The City has undertaken to remove and provide for the removal of blight and dilapidated structures in Mannington, through a series of efforts, including acquisition and demolition by the City in some instances; however, these efforts have increased the properties that now must be maintained by the City. Whereas, the notice and public auction requirements of West Virginia Code 8-12-18(b) stand as an impediment to the City's ability to dispose of these lots inasmuch as the auction process is a time consuming one that involves legal fees and creates extra work on departments that are understaffed. Also, since the market for such properties is limited, there is also the risk of losing potential revenue from property that undersells at an auction.

Proposed Solution

The City of Mannington desires to sell real property valued at less than \$15,000 by negotiation and transfer without the requirement for public auction provided the sale of any property is deemed to be for a public purpose by municipal resolution, adequate notice is provided to the public, and the sale is for adequate consideration, which may consider fair market value.

4. Relief from Party Affiliation Requirement for Municipal Non-Partisan Elections & Building Commission Appointments.

Issue Category: Organization

The current state law provides that no team of poll clerks or team of election commissioners may consist of two persons with the same registered political party affiliation or two persons registered with no party affiliation. The state code also mandates that not more than two-thirds of the total number of members of the Building Commission shall be from the same political party

Specific Legal Barrier

Problem Caused by Legal Barrier

Per state law, election officials must be of differing/opposing party affiliations regardless if the election is non-partisan. The term "team of poll clerks" or "team of election commissioners" means two (2) persons appointed to perform the specific functions of the office: *Provided*, that no team of poll clerks or team of election commissioners may consist of two (2) persons with the same registered political party affiliation or two (2) persons registered with no political party affiliation.

The City proposes to be exempted from the requirements of WV Code 3-1-29(4). A change to this law as it pertains to non-partisan elections would make it less difficult to obtain workers to serve as election officials. Furthermore, neither the election officials, nor the voters, are apprised as to the party affiliation of the candidates on the respective ballot. This requirement is unduly burdensome for municipalities that conduct non-partisan elections.

In a small city, it is often difficult to find a willing and qualified person who also has the correct political affiliation to serve as a poll worker or as a Building Commissioner.

Proposed Solution

The City proposes to be exempted from the requirements of WV Code 3-1-29 (4) and 3-33-3. These changes would eliminate the burden of finding an adequate number of poll workers for the City's non-partisan elections which has frequently required getting workers from outside the City limits. Since party affiliation has no part in the City's elections and the party affiliation of no candidate is on the ballots, this would aid the City in its goal of a well-run election.

The same applies to the requirement of WV Code 3-33-3. Exempting the City from the two-thirds requirement would ensure that the best qualified individuals are appointed as commissioners.

HOME RULE PUBLIC HEARING ON MAY 2, 2022

Mayor Lora Michael called to order the public hearing on the City's Home Rule application at 6:00 p.m. at city hall. Those in attendance were Mayor Michael, Councilmembers Kris Bates, John Craw, Ken Fletcher, Tim Fluharty, Roger Russell. Others attending were City Clerk Michele Fluharty, Street/Water Superintendent Ted Nice, City Employee Heather Fluharty, Visitors Bill Michael and Doug Hayes.

Mayor Michael began the meeting by explaining Home Rule and the city's reasons for applying. She said most of the surrounding towns and cities have the 1% sales tax.

The meeting was then opened for public comments or questions.

The only speaker was Doug Hayes who lives outside the city limits but wanted to know if there would be any impact on him and others who live outside the city. Michael explained that the 1% sales tax is based on the 26582 and as a part of the application, a list of the applicable zip codes must be submitted. Hayes asked how they differentiate the zip code and Michael said it is based on the zip + 4 numbers. Hayes thanked the mayor and council for answering his questions.

There were no other comments. The hearing adjourned at 6:20 p.m.

ORDINANCE #468

AN ORDINANCE OF THE COUNCIL OF THE CITY OF MANNINGTON ADOPTED PURSUANT TO THE PROVISIONS OF WEST VIRGINIA CODE 8-1-5A AUTHORIZING THE CITY OF MANNINGTON TO SUBMIT A WRITTEN HOME RULE PLAN TO THE MUNICIPAL HOME RULE BOARD IN ORDER TO PERMIT THE CITY OF MANNINGTON'S PARTICIPATION IN THE MUNICIPAL HOME RULE PROGRAM.

WHEREAS, in 2019, the West Virginia Legislature has made the Municipal Home Rule Pilot Program a Permanent Program created pursuant to the provisions of West Virginia Code 8-1-5a to allow participation by all municipalities; and

WHEREAS, the City of Mannington desires to participate in said program and has prepared a written home rule plan, which plan complies with the provisions of the aforementioned code section: and

WHEREAS, a public hearing on the said plan was scheduled for May 2, 2022 at 6:00 p.m., or as soon thereafter as the matter could be heard at 206 Main Street, Mannington, WV 26582 a notice of said public hearing was published as a Class II legal advertisement in the Times West Virginian, the only newspaper of general circulation in Marion County, West Virginia on March 31, 2022 and April 7, 2022, all as required by the aforementioned code section; and

COUNCIL MEETING OF MAY 16, 2022

The second regular monthly meeting of the Mannington City Council, with Mayor Lora Michael presiding, was held Monday, May 16, 2022 at 7:00 p.m. at city hall. Council members attending were Kris Bates, John Craw, Tim Fluharty and Roger Russell.

The minutes from the last regular meeting and the public hearing on the Home Rule application were approved as read. Russell made the motion. Craw seconded it and all approved.

The first item of Old Business was the second and final reading of Ordinance #468 which authorizes the filing of the Home Rule application. Fluharty made the motion to read the heading only. Russell seconded the motion and it carried. Mayor Michael read the heading. Russell made the motion to adopt Ordinance #468. Bates seconded the motion and all approved.

Next was the second and final reading of Ordinance #469 which approves the acquisition of three FEMA properties. Bates made the motion to read the heading only. Russell seconded the motion and it carried. Michael read the heading. Bates made the motion to adopt Ordinance #469. Craw seconded the motion and it carried.

The second and final reading of Ordinance #470 which amends the C-1 District in the zoning regulations was the final ordinance to be considered. Russell made the motion to read the heading only. Bates seconded the motion and it carried. Michael read the heading. Fluharty made the motion to adopt Ordinance #470 which allows commercial gaming and entertainment establishments as permitted/conditional uses in the C-1 Downtown Historic/Commercial District. Craw seconded the motion and all approved.

Councilman Fluharty asked if the kayak launch at Hough Park was still in the works. Michael said she had not heard anything about it since she took office but asked Fluharty if he wanted to take on that project. Fluharty said he would. In New Business, the bids for the city's liability insurance were opened. The two received were: Assured Partners \$74,449.53 and WV Corp 47,937.00. Craw made the motion to accept WV Corp's proposal pending review of both proposals. Russell seconded the motion and it carried.

Quotes for the flower baskets for the downtown light poles were the next item on the agenda. The only bid received was from Mountaineer Florist for \$1,820. Councilman Fluharty said Anthony from Something Special contacted him to say he would give the city a 30% discount on the flowers, but he did not submit a quote. In order to cut the cost, Council agreed that the city would just purchase the flowers and the city guys would put in the baskets.

Repairs on the 2016 Ford Explorer cruiser were discussed. Chief of Police Jim Rigsby said he is waiting on the recall parts for the tow links from Corwin Ford and the estimate for the other repairs is \$2,800. Rigsby said both control arms are bad. Russell said it looks like it is time to start looking for a replacement for the Explorer. Craw asked about grants. Rigsby said he has looked but hasn't found any.

Rigsby introduced Josh Payton who has applied for a job with the police department. The physical ability testing is scheduled for May 31st and if they pass it, then the psychological testing will be scheduled. Discussion followed about the number of officers needed and Michael said she would like to see three full time officers and one part time.

In his department report, Rigsby said the Dodge truck repairs are complete; however, he was told the problem may re-occur, but it could be soon or years down the road. Fluharty asked if Rigsby had any info on the damage to his truck that took place in the city hall parking lot. Rigsby said he would talk to him after the meeting.

Superintendent Ted Nice said they flushed the air out of the lines, got the trailhead restroom opened for the summer months and two dumpsters were filled at Saturday's Clean Up Day.

City Clerk Michele Fluharty said she submitted the paperwork to the PSC for the sewer rate increase. She said if no protests are received within the 30

days, the PSC will then act. Fluharty also said she received correspondence from the Marion County Commission concerning the plans to cut back on services at the Veterans' Hospital in Clarksburg. She asked if council wished to consider an ordinance opposing any plans to close or reduce VA Hospitals and all agreed they would.

The outstanding bills were reviewed. Craw made the motion to approve payment of the outstanding bills. Fluharty seconded the motion and it carried.

Fluharty made the motion to adjourn. Craw seconded the motion and it carried. The meeting adjourned at 7:45 p.m.
