Collection began July 1, 2017. To date we have received \$435,667.56.		
Beginning July 1, 2017, the B&O tax rate for retail was reduced from .0015 to .0005. The reduced rate has resulted in reduced revenues of \$75,557.57 since July 1, 2017.		
The net revenue gain because of the 1% tax is \$360,109.99.
